Thanks Derek and appreciate you attending site this afternoon.

Roads & Drainage have engaged Fulton Hogan to be onsite tomorrow morning to perform CCTV to determine the condition of the drainage network.

We have also instructed them to clean some of the pits in the View Point & Prospect Hill Roads area, which show signs of some silt, leaf litter and refuse but nothing that appears to be impacting the efficiency of the network.

Derek has strongly recommended that directive be put to the residents within the area to cease all irrigating of their property's until the water source issues have been resolved.

The SEW crews are continuing investigations of their assets and have made some preliminary repairs to a burst water main (upstream) on the opposite side of the freeway. These repairs were completed last week. We hope to receive a full report of their investigations and details of works in the coming days.

As an FYI, our contractor is performing investigative excavation works at Charlesworth St / Waller Place, in an attempt to determine the source of the water which is bubbling up and damaging the roads. This as a last resort, as we have exhausted all possibility of defects from the relevant stakeholders with assets in the area.
