Good afternoon, all,

We are working with VicSES to transition the management of the site from response to recovery to the Mornington Peninsula Shire under agreed terms. This phase will see the Shire continue to provide support to you while the extensive investigations continue.

Traffic update

The Department of Transport and Planning, in conjunction with the SES are working on reopening Pt Nepean Road. Speed limits will be reduced for that section of road and fencing will be installed along the resident side of the road with water filled barriers on the Bay Trail side. This is designed to stop people parking in the immediate vicinity. The re-opening of Pt Nepean Road will reduce the through traffic that had been moving along the residential streets, making it safer for residents along those streets. Traffic management for local McCrae roads/streets will remain in place until further notice.

Security update

CCTV cameras and signage is being installed today in several strategic locations. To complement the static surveillance, a private security firm has been engaged to provide mobile patrols through the area, particularly at night. Victoria Police have positioned a surveillance camera on Pt Nepean Road and have dedicated tasking for police units to patrol the area. As always, if suspicious activity is observed, or people are seen inside the exclusion zone, please contact 000.

Investigation update

Beginning today, geotechnical experts are installing monitoring equipment within the exclusion zone. Information will be provided back to council at intervals yet to be determined, however we will provide information back to you at the earliest opportunity. This part of the investigation is critical to determining the viability of access to properties.
