Good afternoon, all,

Security update

On Friday we had CCTV cameras installed around the exclusion zone, providing 24-hour coverage, including licence plate recognition. Further cameras will be installed in the coming days. Both Victoria Police and our nominated security company have been conducting regular patrols around the exclusion zone, monitoring for suspicious people and vehicles. Any concerns relating to suspicious behaviour should be directed to 000 (if currently being observed), or Crimestoppers – 1800 333 000 if you

hear any information 2nd or 3rd hand.

Investigation update

Ground monitoring equipment has been installed and measurements are now being taken. At this stage I do not have a timeframe for any results from that monitoring.

The Department of Transport and Planning (DTP) and SES made the decision to reopen Pt Nepean Road on the weekend. An assessment provided by DTP indicated that should a further landslide occur, there would be no impact to Pt Nepean Road.

Recovery Committee update

The make-up of the McCrae Landslide Recovery Committee is expected to be finalised today. There will be representatives from council applicable to aspects of recovery, including the building surveyors, infrastructure, and emergency management teams. We would also like to have representation from the affected residents – 1 or 2 people to provide direct input into the committee and then disseminate information back to the affected residents. Request – as a collective, could the affected residents please nominate up to two community representatives to participate in the recovery committee, and provide details to me by **Friday 31 Jan**.
