Hi all,
 At 4.00pm this evening a community meeting was undertaken with residents impacted by the Landslip.
 The following was discussed and undertaken;

- All impacted residents were addressed by MPS staff, Geotechnical Engineer – Davin Slade, SES and VicPol
- Residents were advised MPS has only made the site secure for protection of further harm to human life
- All residents impacted by the slip should contact their insurance agencies if not all ready, it was advised by the residents that insurances agencies have been contacted.
- Geotechnical Engineer, advised from his expertise knowledge what has taken place and from site inspections undertaken at 3.00pm there is still a significant high risk for further potential slips to occur until the area is made safe to dwellings No. 3 Penny Lane and 3/613 Point Nepean Road MCCRAE VIC
- It was advised that all dwellings except two, could be re-entered based on advised form the Geotechnical Engineer as they are low risk. Prior to entry we walked around their properties and showed them risks and what to look for, it also advised they notice any unusual groundwater activity to record it and advise Andrew Joseph.
- Andrew Joseph recorded all emails address and was advised he would be single point of communications for the residents.

Next Steps.

- Legal team need to advise our insurance agencies of the slip and potential claims, should also provide advice on what works they would like MPS to undertake, ie Geo investigation, flood mapping, etc.
- MPS will require to undertake daily site inspections, this will need to be arranged via DM Roads along with a process for escalation if any movements are detected onsite until area is made safe.
- The drainage system up along View Point Road will need to be inspected and advice on what maintenance works are required to fix the existing system.
- MPS – AJ to look at what we need to do for recovery period of the works.
- MPS – legal to advise what we can do to assist residents in coordination of claims with the other insurance agencies.
- MPS – AJ to provide regular updates to residents as required.
