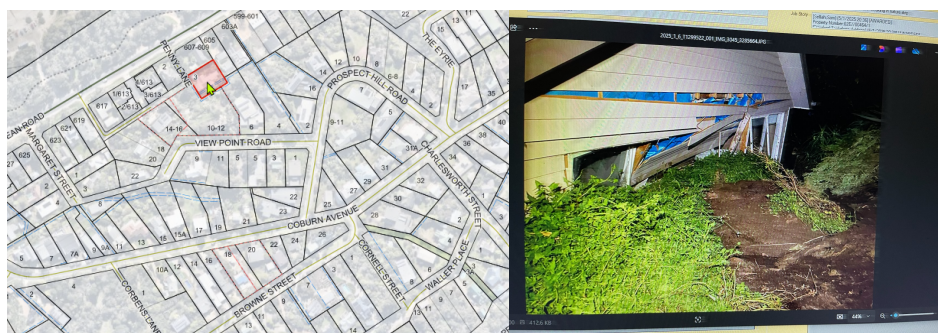

Please be informed that Shire has been notified of a landslide impacting the dwelling at 3 Penny Lane, McCrae. The landslide occurred on the afternoon 5 January, with the slip occurring in private properties and no injuries reported. The Shire's Municipal Building Surveyor will be attending site for assessment and as further details are provided, we will upload more information onto Sharepoint.

At this stage Shire are liaising with South East Water regarding their investigation into a possible storm water concern or other leak(s), and SEW are responsible for communication with residents regarding this issue.
