Hi Renae, We just returned from a meeting with owners and insurers regarding the necessary works to ensure public safety.

Executive Leadership Update - 9 January 2025

Work is commencing to reduce the hydrostatic loads on the premises, which will result in water being pumped via the surface along Penny Lane until the water source is known.

To date the following has been done with no evidence of the cause of the water discharge from View Point:

- 1. Trace die testing of the stormwater lines;
- 2. Hydrant Ground-ball inspections for leaks;
- 3. Water sampling of the landslip water, stormwater in View Point drainage, and Charlesworth St (in front of ____, where a leak was reported in the road back in September 24 and again pre-Xmas to SE Water and Council.
- 4. Water meter inspection for excessive flows

Subject to water lab results, the water source could just be a natural spring. In that case, the state government (Resources Vic), which manages the Water Act 1989 and Groundwater Management Areas, should be contacted.

We will inspect site conditions daily during the working week. Over the next few days, the insurers and owner have commented on undertaking works as previously communicated and reviewed by PSM Engineers as a short-term solution.

Internally; CIrs, ELT, Engineering, Environmental Health have been notified.

At this stage, based on the PSM initial finding, no residents along Point Nepean are at risk, provided the short-term works are undertaken.


Hi,

I drove the past the site of the current slip on my way into the office and notice water flowing down Penny Lane. On inspecting the site, I noticed significant water still flowing out from the property, with slit content within the water. (This indicates the land still has a significant high-risk of slipping again)

Noting no major rain events have taken place to generate this amount of water runoff, it then suggests there is a break in a domestic water line somewhere.

It is recommended the residents in area should be notified to turn-off water supplies one by one to eliminate the source of the flow, this should be overseen by the Shire to reduce our risk and identify where the source is coming from. This should be overseen by those managing the current incident.
